The University came into existence on 15 August 2020 vide Notification dated 14.08.2020.

The Delhi Skill and Entrepreneurship University (DSEU) is looking for short-term appointment of **Visiting Faculty** for handling different academic responsibilities related to delivery of the curriculum on Soft Skills.

**Role Description**

<b>Role Scope</b>
Deliver blended (online and in-person) experiential learning sessions on the topics of Self Awareness and Collaboration to DSEU’s students across campuses in New Delhi
Prepare lesson plans based on the curriculum framework, collect in-session assessment, submit session report and observations
Incorporate in-session feedback based on observation by lead trainers.

1. Above 8 years of facilitation experience in delivering soft skills, social emotional skills or developing job readiness skills.
2. Experience of facilitating using experiential methods - like group work, expressive arts, drama, outbound learning, etc. will be given preference.
3. Experience of having worked with youth (16 to 25 years) of age will be given priority.
4. Educational Qualification: Degree or equivalent certification
5. Attitude: Open, Agile, Enjoy working with young people, Compassion and patience
6. Preferred location: NCR Delhi
