An open PhD viva voce of the candidate has been conducted; d. The Candidate has published two research papers from his/her PhD work, out of which at least one is in a refereed journal. e. The candidate has presented at least two papers based on his/her PhD work in conferences/seminars sponsored/ funded/ supported by the UGC / ICSSR/ CSIR or any similar agency.
