- 1. Reservation benefits will be available to the SC/ST/OBC/PwBD in accordance with the Instructions/Orders Circulars issued from time to time by the Govt. of Delhi and DoPT, Govt of India. In case if there is any change in reservation rules/norms in future they will be applied on the date of selection.
- 2. Such candidate will be adjusted against unreserved point of the reservation roster In other words, when a relaxed standard is applied in selecting an SC/ST/OBC candidate, for example in the age limit, experience, qualification, extended zone of consideration larger than what is provided for general category candidates, etc., the SC/ST/OBC candidates are to be counted against reserved vacancies.
