In the exercise of the power conferred under section 22(1) read with section 32 of Delhi Skill and Entrepreneurship University Act 2019, the Board of Management of Delhi Skill and Entrepreneurship University makes the following Regulations, namely;

## **1. SHORT TITLE, APPLICATION AND COMMENCEMENT:**

- a. These Regulations shall be called as the Delhi Skill and Entrepreneurship University (FACULTIES AND DEPARTMENT/ SCHOOL OF STUDIES) Regulations -1(I), 2024.
- b. They shall be applied to all Campuses, Departments and School of Studies of Delhi Skill and Entrepreneurship University.
- c. They shall come into force from the date of notification.

## 2. Regulation 1.1 Faculties:

The University shall have the following Faculties, namely:

- I. The Faculty of Agriculture and Allied Skills (FAAS);
- II. The Faculty of Allied Medical Sciences and Healthcare Skills (FAMSHS);
- III. The Faculty of Design Skills (FDS);
- IV. The Faculty of Architecture and Civil Engineering Skills (FACES);
- V. The Faculty of Business, Finance and Managerial Skills (FBFMS);
- VI. The Faculty of Chemical Engineering Skills (FCES);
- VII. The Faculty of Computational and IT Enabled Skills (FCITES);
- VIII. The Faculty of Converging Scientific and Technological Skills (FCSTS);
  - IX. The Faculty of Electronics and Electrical Engineering Skills (FEEES);
  - X. The Faculty of Entrepreneurship Skills (FES);
- XI. The Faculty of Language and Communication Skills (FLCS);
- XII. The Faculty of Mechanical Engineering Skills (FMES);
- XIII. The Faculty of Scientific Skills (FSS);
- XIV. The Faculty of Social Science and Life Skills (FSSLS);
- XV. The Faculty of Tourism and Hospitality Skills (FTHS); and
- XVI. Such other Faculties as may be appended on the approval of Academic Council and Board of Management.

## **Regulation 1.2. Departments/ School of Studies/ Centers:**

- (i) The Faculty of Agriculture and Allied Skills (FAAS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Agri Business Management;
  - b. Department of Dairy Management;
  - c. Department of Farmhouse Management;
  - d. Department of Forestry;
  - e. Department of Organic Farming and Crop Management;
  - f. Department of Poultry Farm Management;
  - g. Department of Vertical Farming; and
  - h. Such other Departments/ School of Studies/ Centre as may be created and assigned to it from time to time.
  - (ii) The Faculty of Allied Medical Sciences and Healthcare Skills (FAMSHS) shall consist of the following Departments/ School of Studies/ Centers, namely:
    - a. Department of Allied Medical Science;
    - b. Department of Allied Health Care Science;
    - c. Department of Pharmaceutical Science;
    - d. Department of Optometry & Vision Science;
    - e. Department of Rehabilitation Science;
    - f. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
  - (iii) The Faculty of Design Skills (FDS) shall consist of the following Departments/ School of Studies/ Centers, namely:
    - a. Department of Crafts Design;
    - b. Department of Digital Media Design;
    - c. Department of Fashion Design;
    - d. Department of Garment Fabrication Technology;
    - e. Department of Gems and Jewellery Design;
    - f. Department of Product Design;
    - g. Department of Fine Arts;
    - h. Department of Performing Arts;
    - i. Department of Social Media Management;

- j. Department of Interior Design; and
- k. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (iv) The Faculty of Architecture and Civil Engineering Skills (FACES) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Architecture;
  - b. Department of Civil Engineering;
  - c. Department of Urban Infrastructure and Planning;
  - d. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (v) The Faculty of Business, Finance and Managerial Skills (FBFMS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Banking, Financial Services and Insurance;
  - b. Department of Business Administration;
  - c. Department of Business Process Management;
  - d. Department of Economics;
  - e. Department of E-Commerce;
  - f. Department of Human Resource Management;
  - g. Department of International Business Management;
  - h. Department of Office Management;
  - i. Department of Retail Management;
  - j. Department of Warehouse Management;
  - k. Department of Supply Chain Management;
  - Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (vi) The Faculty of Scientific Skills (FSS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Physics;
  - b. Department of Chemistry;
  - c. Department of Mathematics;
  - d. Department of Statistics;
  - e. Department of Life Sciences; and

- f. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (vii) The Faculty of Chemical Engineering Skills (FCES) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Chemical Engineering;
  - b. Department of Petrochemicals;
  - c. Department of Polymer Science and Technology;
  - d. Department of Metallurgy and Mining; and
  - e. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (viii) The Faculty of Computational and IT Enabled Skills (FCITES) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Artificial Intelligence and Machine Learning;
  - b. Department of Augmented Reality;
  - c. Department of Computer Engineering;
  - d. Department of Computer Science and Applications;
  - e. Department of Data Analytics;
  - f. Department of Library and Information Science;
  - g. Department of Virtual Reality; and
  - h. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (ix) The Faculty of Converging Scientific and Technological Skills (FCSTS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Biosystem Inspired Engineering;
  - b. Department of Biotechnology and Bioinformatics;
  - c. Department of Computer Aided Drug Design;
  - d. Department of Cognitive Neuroscience;
  - e. Department of DRONE Technologies;
  - f. Department of Nanotechnology;
  - g. Department of Nano-Biosensor Technologies;
  - h. Department of Natural Language Programming;
  - i. Department of Quantum Technologies;

- j. Department of Quantum Computing;
- k. Department of Sustainability Sciences;
- Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (x) The Faculty of Electronics and Electrical Engineering Skills (FEEES) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Electrical Engineering;
  - b. Department of Electronics Communication Engineering;
  - c. Department of Instrumentation and Control Engineering;
  - d. Department of Internet of Things (IoT);
  - e. Department of Networking and Security Informatics; and
  - f. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (xi) The Faculty of Entrepreneurship Skills (FES) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Innovation & Entrepreneurship;
  - b. Department of Intrapreneurship;
  - c. Department of Small Business Entrepreneurship;
  - d. Department of Social Entrepreneurship;
  - e. Department of Customer Service Management;
  - f. Department of Start-up Entrepreneurship; and
  - g. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (xii) The Faculty of Language and Communication Skills (FLCS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of English;
  - b. Department of French;
  - c. Department of German;
  - d. Department of Hindi;
  - e. Department of Japanese;
  - f. Department of Journalism;
  - g. Department of Mandarin (Chinese);

- h. Department of Russian;
- i. Department of Spanish;
- j. Department of Korean Language; and
- k. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (xiii) The Faculty of Mechanical Engineering Skills (FMES) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Automobile Engineering;
  - b. Department of Mechanical Engineering;
  - c. Department of Mechatronics;
  - d. Department of Printing and Packaging Technology;
  - e. Department of Robotics and Automation;
  - f. Department of Tool and Production Engineering;
  - g. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (xiv) The Faculty of Social Science and Life Skills (FSSLS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Aesthetics & Beauty;
  - b. Department of Cosmetology;
  - c. Department of Gym Management;
  - d. Department of Psychology;
  - e. Department of Sports Management;
  - f. Department of Yoga, Wellness and Meditation; and
  - g. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.
- (xv) The Faculty of Tourism and Hospitality Skills (FTHS) shall consist of the following Departments/ School of Studies/ Centers, namely:
  - a. Department of Event Management;
  - b. Department of Food Production;
  - c. Department of Front Office Management;
  - d. Department of Facility Management;
  - e. Department of Home Science

- f. Department of Hospital Facility Management;
- g. Department of Hotel Management;
- h. Department of Tourism and Cultural Affairs;
- i. Such other Department/ School of Studies/ Center as may be created and assigned to it from time to time.

**Regulation 1.3:** Each faculty shall have a Dean or Associate Dean. An Associate Dean will be appointed when a Professor in the Departments/Schools of Studies/Centers associated with the Faculty is not on the permanent roll of the university. An Associate Dean can also be appointed from among experts engaged by the university as Emeritus Professors, Adjunct Professors, Honorary Professors, or External Experts with over 15 years of experience in the related skill sectors.

**Regulation 1.4:** A department listed in this Regulation will be named as a Department if it has regular faculty on the roll; otherwise, it will be named as Centre as notified by the Registrar upon approval of the Vice-Chancellor.

**Regulation 1.5:** The Head of the Department will be appointed by the Vice-Chancellor as per the provisions in the Act and Statute. The Director of a Centre will be appointed by the Vice-Chancellor for a period of two years. The Director of a Centre will hold an equivalent position to the Head of the Department.

**Regulation 1.6:** A Faculty member serving the university will be associated with a primary Department/School of Studies/Centre. However, if permitted by the Vice-Chancellor, he/she may also be associated with more than one Department/School of Studies/Centre. In such cases, he/she will serve as adjunct faculty for the other Department/School of Studies/Centre, which is not his/her primary affiliation.
