3. The teaching hours for the Delhi Skill and Entrepreneurship University are from 8:00 AM to 8:00 PM, and the office hours for other departments are from 9:00 AM to 6:00 PM. The office timings of the University are 9:30 AM to 6:00 PM on all working days, with holidays observed as notified by the Central Government and the Government of NCT of Delhi.

4. **Powers and Functions of the Delhi Skill and Entrepreneurship University as per the DSEU Act 2020:**

- a. The Delhi Skill and Entrepreneurship University is empowered to comply with the National Skills Qualification Framework and the framework for applied sciences courses. It exercises autonomy in financial, administrative, and academic matters, developing credit frameworks and curriculum packages aligned with national standards. The University defines norms for skills education, imparts instruction, and awards degrees, diplomas, and certificates. It also sets assessment norms, conducts examinations, recognizes industries for practical training, and assesses prior learning. The University is responsible for establishing infrastructure, appointing staff, collaborating with institutions, and promoting entrepreneurship.
- b. Additionally, the University manages residential facilities, creates and maintains funds, acquires property, and borrows money with government

approval. It assesses educational and training needs, cooperates with industries, and prescribes codes of ethics and conduct. These functions support the University's mission to provide effective skill-based education and training, ensuring adherence to ethical standards and promoting student and employee welfare.

- c. Training and teaching related to the degree, diploma, and certificate programs of the University shall be conducted in accordance with the Ordinances and Regulations. The courses, curricula, and the authorities responsible for organizing the training and teaching of these courses shall be as prescribed by the Ordinances.

5. Objective of the University

- a. To establish a world-class institution of quality in applied sciences and skills education recognized by industry, both nationally and internationally.
- b. To develop employable human resources and assist in placement for the growth and development of the economy.
- c. To train individuals in the field of applied sciences and skill proficiencies and competencies at different levels, based on principles of applied sciences and skills education.
- d. To establish world-class standards of training, teaching, and integrated research.
- e. To provide opportunities for flexible learning systems and create a platform for lifelong learning in applied sciences and skill development.
- f. To develop linkages with industries to provide applied sciences and skills education according to their requirements and expectations.
- g. To design and implement applied sciences-oriented programs jointly with industries.
- h. To promote entrepreneurship development initiatives and create an inspiring ecosystem for experimenting with ideas.
- i. To ignite the spirit of innovation, creativity, and experimentation.
- j. To maintain the highest level of transparency in matters of admission, appointments, evaluation, accreditation, administration, and finance.
- k. To set up business incubators, technology transfer companies, and innovation foundations.
- l. To publish books, journals, periodicals, reports, and scholarly articles in relevant areas as prescribed.

m. To do all such things as are incidental, necessary, or conducive to the attainment of all or any of the objects of the University.

- To become a leading partner in the sustainable growth of the industry and the country.

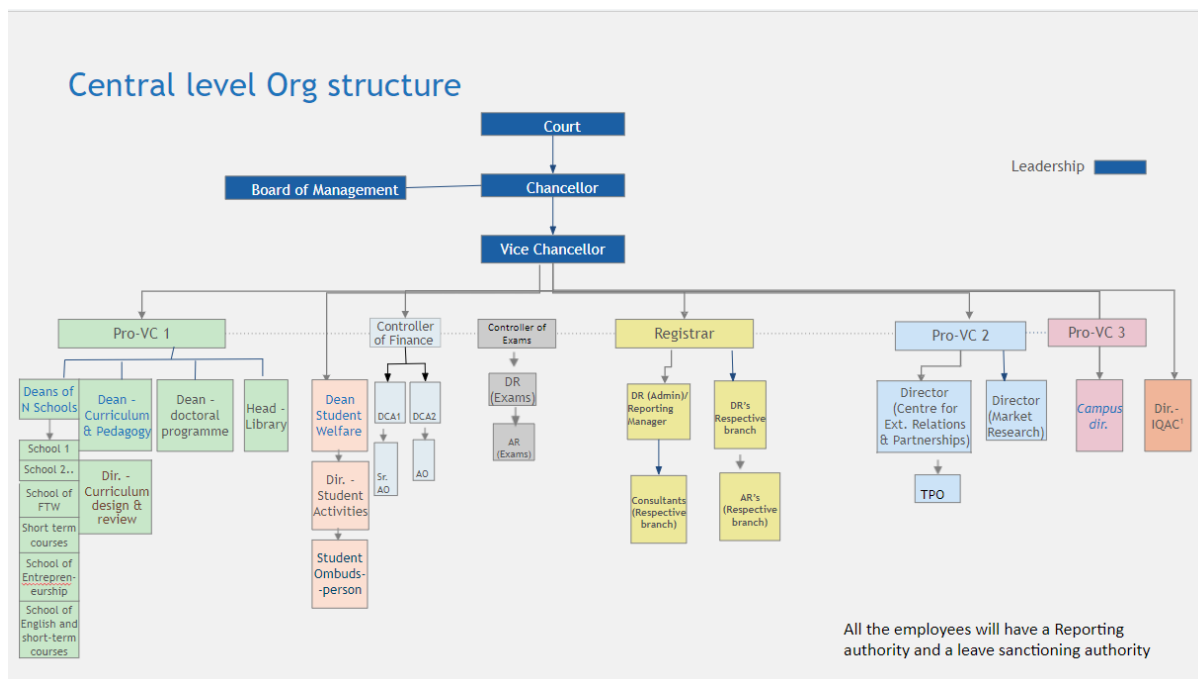
8. MISSION
