

1. Expressions of Interest are invited for engagement as Distinguished Professors from individuals who have held high positions such as
 - a) Vice Chancellor/Pro-Vice Chancellor of Central/State University,
 - b) Directors of National Level Institutes funded by the Government of India,
 - c) Emeritus Professors of UGC, CSIR, ICAR, ICMR, INSA or any other National level body, and
 - d) CEOs, CTOs, COOs, CFOs of Large or Mid Cap companies listed on NSE or BSE or have been conferred Padma Awards.
2. A brief CVs along with a write-up outlining how you intend to contribute to DSEU be submitted for consideration by the expert committee constituted for the selection process.
3. The committee may invite the distinguished individuals for interaction. The invitation shall be extended on recommendation of the experts committee chaired by the Vice-Chancellor and approval of the recommendations by the Board of Management of the university.
4. An honorarium of 5000/- per one-hour lecture shall be paid to the distinguished professor or revised as per UGC guidelines.
5. Distinguished professors shall be invited for a series of lectures spanning one or two semesters, with travel and other expenses reimbursed as per actuals.
